STATUTES of the BODY ART CONTEST **Fascination of Wonderland**

The site of the contest – the exhibition “Baltic Beauty World 2008”

Time: November 2, 2008

Participants – team consisting of 1 or 2 stylists, make-up artists, visagistes, hairdressers.

Awards – the team, awarded the first prize receives as a prize a prepaid trip and participation at the WORLD BODY ART contest in Austria. The teams awarded the II and III prizes receive diplomas, cups and valuable prizes. The rest of the participants receive diplomas for participation in the contest and promotion prizes.

International jury consisting of five people evaluates the contest results. The task of the commission is to prepare the participants for starting the contest work, examination of models before the start of the work, compliance to the contest rules during the course of the contest.

Submission of applications with the motto of the associative image and the contest participation fee have to be submitted to the Latvian Association of Stylists, 193/D, Brīvības str., Rīga, LV-1039. It may be submitted by FAX: 7542409,

Participation fee for the team is Ls 60

The meeting of the participants with the contest organizers will be announced separately.

CONTEST RULES

A team consisting of two or one artist, working with one model and creating a unified image participates in the contest.

The statutory commission supervises the course of implementation.

The contestants prepare the model from bottom to the décolleté at the premises, provided by BT 1. The allotted time constitutes four hours.

The final design of the model is carried out in front of the jury and the audience at the contest site.

It is allowed to cover up to 30 % of the body with other material; the rest has to be painted. The painting has to be complimented with special effects, pasting and texture not exceeding 30 %. It is not allowed to use for painting materials which are not suitable or which are harmful to the body. The instruments have to be sterile.

Work done at the contest site:

- 1) decoration of the head – 60 minutes (both contestants may work with it);
- 2) arrangement of the make – up accessories – 10 minutes;
- 3) make – up from the hair to the décolleté – 120 minutes (both contestants are engaged);
- 4) arrangement of the model – 10 minutes.

Evaluation of the work:

At the workplaces of the teams the technical implementation of the work (the quality and level of complexity of the make – up, the body art, the applied special effects, the texture, the applications, the decoration of the head, the techniques applied, complexity and correspondence to the image) are being evaluated.

On the stage the general image is being assessed together with the movement and music (the music recording has to be submitted by the applicants on a CD) according to the following criteria:

- 1) the technique and correspondence to the image of the head decoration;
- 2) the implementation technique and correspondence to the image of the make – up and body art;
- 3) the application and correspondence to the image of the special effects, textures;
- 4) correspondence of the general image and movement to the music.

Maximum evaluation score is 30 points.

Up to 5 points may be deducted for the violation of contest rules.
